**INDEPENDENT AUDITORS' REPORT**

To the Members of  
Bermuda Zoological Society

We have audited the statement of financial position of the Bermuda Zoological Society (the "Society") as at March 31, 2008 and the statements of operations and changes in fund balances for the year then ended. These financial statements are the responsibility of the Executive Members. Our responsibility is to express an opinion on these financial statements based on our audit.

Except as explained in the following paragraphs, we conducted our audit in accordance with auditing standards generally accepted in Bermuda and Canada. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

In common with many non-profit organizations, the Society derives revenue from donations and fund raising projects, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Society and we were not able to determine whether any adjustments might be necessary to revenues, excess of revenues over expenditures, assets and fund balances.

The financial statements of the Society have been prepared on a cash basis. In this regard, the financial statements are not in accordance with generally accepted accounting principles.

In our opinion, except that the financial statements have been prepared on a cash basis as described in the preceding paragraph and except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of revenues, these financial statements present fairly the financial position of the Society as at March 31, 2008 and the results of its operations and changes in fund balances for the year then ended in accordance with accounting principles generally accepted in Bermuda and Canada.

# Notes to the Financial Statements

March 31, 2008

## 1. DESCRIPTION OF BUSINESS

The Bermuda Zoological Society (the "Society") is a non-profit support organization set up primarily to provide assistance in maintaining the Bermuda Aquarium and Zoo located at Flatts Village. The Society's aim is to inspire appreciation and care for Bermuda's island environment through education, conservation, animal care and family fun. The Society also operates a gift shop located at the Aquarium.

## 2. ACCOUNTING POLICIES

### Basis of preparation

The financial statements have been prepared in accordance with accounting principles generally accepted in Bermuda and Canada except that they are prepared on a cash basis instead of on the accrual basis, and a statement of cash flows has not been included as it would not provide any additional useful information. The Society has adopted the following significant accounting policies:

### Inventory

Gift shop inventory is carried at the lower of cost and net realizable value.

### Donated services

The Society records the value of donated services at fair value when the fair value can be reasonably estimated, and the services are normally purchased and would be paid for if not donated.

### Capital assets

Capital assets are expensed in the year of purchase. During the year, capital assets purchased and expensed of \$Nil (2007 – \$2,700) are included in membership development and office expenditures in the statement of operations, \$Nil (2007 – \$18,149) in the concession fund in the statement of changes in fund balances.

### Financial instruments

Financial assets and financial liabilities are initially recognized at fair value and their subsequent measurement is dependent on their classification as described below. Their classification depends on the purpose, for which the financial instruments were acquired or issued, their characteristics and the Society's designation of such instruments. Settlement date accounting is used:

#### (a) Classification

Cash – Held for trading  
Investments – Available for sale

#### (b) Held for trading

Held for trading financial assets are financial assets typically acquired for resale prior to maturity or that are designated as held for trading. They are measured at fair value at the balance sheet date. Fair value fluctuations including interest earned, interest accrued, gains and losses realized on disposal and unrealized gains and losses are included in other income.

Financial liabilities designated as held for trading are those non-derivative financial liabilities that the Society elects to designate on initial recognition as instruments that it will measure at fair value through other interest expense. These are accounted for in the same manner as held for trading assets. The Society had not designated any non-derivative financial liabilities as held for trading.

(c) Available for sale financial assets are those non-derivative financial assets that are designated as available for sale, or that are not classified as loans and receivables, held-to-maturity and held-for-trading investments. Available for sale financial assets are carried at fair value with unrealized gains and losses included in fund balances until realized when the cumulative gain or loss is transferred to other income.

## 3. CHANGES IN ACCOUNTING POLICIES

a) Section 3855 of the Handbook of the Canadian Institute of Chartered Accountants ("CICA Handbook"), Financial Instruments – Recognition and Measurement. This Section describes the standards for recognizing and measuring financial instruments in the balance sheet and the standards for reporting gains and losses in the financial statements. Under the new standard, financial assets and liabilities are initially recorded at fair value. Subsequently, financial instruments classified as financial assets or liabilities held for trading, financial assets available for sale and derivative financial instruments, part of a hedging relationship or not, have to be measured at fair value on the balance sheet at each reporting date, whereas other financial instruments are measured at amortized cost using the effective interest method.

b) Section 3861 of the CICA Handbook, Financial Instruments – Disclosure and Presentation. This Section establishes standards for presentation of financial instruments and non-financial derivatives, and identifies the information that should be disclosed about them. The Society has made the following classification:

- Cash and time deposits are classified as financial assets held for trading and are measured at fair value.
- Investments in shares are classified as financial assets available for sale and are measured at fair value.

These new standards were applied prospectively as of April 1, 2007 without restatement of prior years figures. Upon adoption of Section 3861 of the CICA Handbook at April 1, 2007, the following was recorded on the balance sheet:

## 5. DONATIONS

Audit fees for the year ended March 31, 2008 are recorded at their fair value of \$15,450 (2007: \$12,000). The actual amount charged for the audit is \$3,090 (2007: \$5,100) with the difference of \$12,360 (2007: \$9,600) being recorded as a non-designated donation to the general fund. All amounts are recorded in the year paid.

## 6. RESTRICTED FUNDS

Funds internally restricted for use are shown in the statement of changes in fund balances. Externally restricted funds represent a donation of land located at Trunk Island.

## 7. RELATED PARTIES

In 1996, the Society set up an Education Endowment Trust (the "Trust"). The Trust was established to provide funding for use by education officers to educate the public on zoological matters. The Trust has its own Trustees and the Society does not control the Trust. During the year, \$500,000 raised through the Capital Campaign was transferred to the Trust.
